NOTICE IS HEREBY GIVEN THAT the Town Board of New Market Township, Scott County, Minnesota, will meet at the New Market Town Hall at 6:30 p.m. on Thursday, September 21, 2017 to consider improvements for the 2018 Street Reconstruction Project for Livery Lane (from Wagon Wheel Trail to Xerxes Avenue); Livery Court (south of Livery Lane); Wagon Wheel Trail (from County Road 91 to Credit River/New Market Township limits); and Xerxes Avenue (from County Road 29 to Livery Lane, all said improvements located within New Market Township pursuant to Minnesota Statutes, Sections 420.011 to 429.111. The areas proposed to be assessed for the project are all those properties abutting or having access to said roads, all located in New Market Township. The total estimated cost of the improvements proposed by New Market Township is \$1,349,539. A reasonable estimate of the impact of the assessment will be available at the hearing. Such persons as desire to be heard with reference to the proposed improvements will be heard at this meeting.
